The most pressing issue is the preemptive legislative strategy to circumvent local ordinances regulating Air BnB. Alternatives to full rental property include requiring property owners to be in their property any time renters are present. DeGuiverville homes are still in purchaser match phase. We are working with block captains to identify at risk properties prior to potential crises.
