Financials:

4120 – Originally budgeted for \$600 for t-shirts. The sale of t-shirts takes 2 to 3 years to sell out. A motion was made to reduce this item to \$200.

5010 – Rags to Riches raised \$1,400. After the net profit is determined one half of which will be returned to Rosedale Neighbors.

6075 – Spoilage due to shortened concerts due to weather resulted in lower sales than anticipated.

7204 – Software purchase for access to "not for profit" databases.
