Aldermanic Report:

Heather Navarro – Provided updates city issues, Aldermanic Board session finished up this week. Alderman Navarro has been working on closing the workhouse and a resolution regarding aerial surveillance in which Alderman Clark Hubbard is on the opposing side of the bill. The city is considering aerial surveillance as a way of addressing crime in the city. The city budget went into effect on July 2020, obviously with COVID there was some deep budget cuts. Board of Alderman did not approve the budget but it still will go into effect. Ways and means committee approved funding for contact tracers, rental assistance and test kits. Updates on neighborhood issues, the Skinker Debaliver traffic study results are back and the tentative date zoom public meeting is scheduled for July 23. Would like to have a public meeting with as many as possible to complete the final phase of the community engagement, recommendations can be made to the alderperson about future project for funding. Polling places for precinct 5 and 6 will be at the old school building on DePere, address is 450 DePere. Forest Park advisory board meets the 3rd Thursday of every month. On their agenda this month is basketball as recreational opportunity in the park. It is not part of the Forest park master plan, but a lot of people are interested as another amenity in the park. The meeting is this Thursday at 4:30 on zoom the information is on the city website search Forest Park Advisory Board to get access to the link. The Pearl project is on hold until various issues are worked. Working with DeGiverville neighbors regarding getting parking spots stripped and signage on the street.

Shameem Clark-Hubbard – No updates.

Delmar Loop Report:

Rochelle L'Ecuyer – Announced that Chicken Out has opened. Last week the Commercial Corridor Committee reviewed and approved with contingency I-tab a beer place. The business will be open in the Link building in Feb. This Wednesday Commercial Corridor Committee will review the B-Leaf a medical marijuana dispensaries. Original B-Leaf was going to be located in the 6000 block of Delmar, but the building was sold. The new proposed location is a building across from the Moon Rise Hotel. Rochelle has been working with students from Olin Business School. The student are assisting her develop a reopening marketing strategies for businesses. Delmar Loop received a grant from Washington University for reopening businesses (ordered sanitizer for the businesses). The businesses completed a survey regarding their business needs to reopen.

Commercial Corridor Committee:

Rochelle L'Ecuyer introduced Jake Baton from the Westend Neighbors to participate. Rochelle is the new chairperson of Commercial Corridor Committee. They discussed having quarterly meetings to address issues along the commercial corridor of Debaliver and Delmar, developing criteria for reviews, developing a more formal structure in process, and creating a more formal committee and meeting. The committee could consist of stakeholders from Westend Neighbors, Skinker and Debaliver, Debaliver (Bussey Bank or Cross Roads) Washington University. She would like to create a formal structure for the Commercial Corridor Committee.

Jake Baton gave an update on Westend Neighbors. Westend Neighbors are undergoing a planning process for the Westend neighborhoods. They are in the process of setting up a development review committee. They are working with Cornerstone for staffing and technical assistance from Washington University Redevelopment Corporation. They have conducted project reviews for a new manufacturing business on Hodiamont that manufactures small lab equipment, a childcare facility on page, and has engaged with Vatterott Home Building in the Westend. Westend Neighbors are interested in the development and new businesses along Delmar that are shared border between the two neighborhoods. With Rochelle L' Ecuyer they discussed how to formalize a process to make sure both neighborhoods are involved in in decision making.

The general outline of this committee is to create a joint committee for participation from both neighborhoods. This committee will streamline processes for businesses to get approval for various permits. The committee will be a different entity from the Commercial District Committee. Further discussion is needed regarding the clarity and function of this proposed committee and the name of the committee.

Proposal is asking to engage the Westend Group with a joint effort to establish a review for the Delmar and Debalivere corridor businesses. **Proposal approved** (Jeff Stoker motion; Mike Stephens 2nd)
