JoAnna Schooler reported that Wash U's first installment will come in July, second will be in the fall. Mike will ask Karen to remind institutional members about making contributions.

Aldermanic report by Heather Navarro:

She has been working on St Louis Budget approval meetings and aldermanic redistricting (going from 28 to 14 alderpersons) She welcomes volunteers to give her some input.

Mayor Jones has formed a stimulus advisory board. Meetings are held virtually and open to public. They have developed top 6 priorities for money allotment.

Beautification Committee: Andy reported on success of Electronic recycling day, plant exchange and Breakfast Garden tour. The Greg Freeman park lawn has been torn up by dogs and he has done some replanting. Dog show is June 15th. Shakespeare in the park is currently going on and the Muny will start on July 25th.

Grace United Methodist Report: University Methodist will be closing and will merge with Grace Methodist. They are interested in helping with Porchfest in any way they can.

Community Engagement Committee. Josh Peck was not able to attend the meeting but he presented the committee purpose to the group in a four minute video. The committee will focus on restarting the Block program and information dissemination. A motion was made to make this a standing committee of the council but Mickey Clarke reminded us that adding a new standing committee requires a by-law revision. For now it will be a special committee and renamed the Neighborhood engagement committee (to avoid confusion with committees with similar names). Josh Peck will be the chair of the committee and has several interested committee members. Andy Cross expressed interest in being involved. Sheryl made a motion to approve the committee and Tracy seconded. The motion carried.

Porchfest Committee: Date is still TBD but will be early fall, awaiting input from Joanna about Wash U events. There are many conflicts with 1st Sat in October including food drive, Westminster Block party and Parkview party. First meeting of committee will be Monday June 21st

Executive Director Report:

We have received 2nd PPP loan money and forgiveness for 1st PPP loan.

Mike has 3 interns so if anyone has any ideas of how they can be used please contact him

He has dealt with complaints from Brinkman monitors and alarms around construction areas

He is working with Tony DiSano to collaborate with DeBaliviere Place
